1 (1) Hearing on the Motion for Summary Judgment brought by Defendants Wells Fargo &
2 Company and Wells Fargo Bank, National Association, is now set for Thursday, June 30, 2016.

3 (2) Plaintiff Sharon Robinson's Opposition to that Motion is now due to be filed by
4 Thursday, June 9. Defendants' Reply in support of their Motion is now due to be filed by
5 Thursday, June 16.

6 (3) At the request of Plaintiff's counsel, and with the agreement of Defendants' counsel,
7 the parties hereby stipulate that the hearing on Defendants' Motion shall be continued for three
8 weeks, i.e. to Thursday, July 21. The parties also stipulate that the additional three weeks of
9 time before the hearing shall be allocated so that the Court is not prejudiced by any reduction in
10 the two weeks it will have to review the completed papers, and that Plaintiff shall have two of
11 those three weeks as extended time, and Defendants shall have one of those three weeks as
12 extended time.

13 (4) Accordingly, the parties stipulate that Plaintiff's Opposition to the Motion shall be
14 filed by Thursday, June 23, and that Defendants' Reply in support of their Motion shall be filed
15 by Thursday, July 7.

16 (5) The parties request that the Court confirm this Stipulation by making
17 it an Order of the Court, by signature on the next page.


