**ORDER FOR PLAINTIFF TO PROVIDE
FURTHER INFORMATION IN
SUPPORT OF FEE WAIVER
APPLICATION**

Re: Dkt. No. 3

9 On December 10, 2015, Plaintiff Brud Rossmann filed an Application to Proceed in
10 District Court Without Prepaying Fees or Costs. Dkt. No. 3. As part of his application, Plaintiff
11 states he has no income from wages or other sources, and no money in cash or in a checking or
12 savings account. However, Plaintiff lists \$1,000 in regular monthly expenses. As Plaintiff does
13 not explain this discrepancy, the Court ORDERS Plaintiff to file a declaration by December 30,
14 2015, explaining the following:

- 15 1) How do you pay your monthly expenses? For each source of money, state the
16 amount you received and what you expect to receive in the future.
- 17 2) Are you married? If so, what is your spouse's full name? If your spouse is
18 employed, what is your spouse's place of employment and monthly salary?
- 19 3) Do you have a bank account? If yes, what is the present balance?
- 20 4) Does the complaint which you are seeking to file raise claims that have been presented
21 in other lawsuits?

22 Plaintiff shall sign the declaration and include the following statement "I declare under the
23 penalty of perjury that the foregoing is true and correct and understand that a false statement
24 herein may result in the dismissal of my claims."

25 **IT IS SO ORDERED.**
