This stipulation in the above-captioned matter is made by and between the attorneys for Plaintiff Stephanie Pamintuan ("Plaintiff") and Defendant Otsuka Pharmaceutical Co., Ltd. ("Defendant").

IT IS HEREBY STIPULATED AND AGREED, by and between the attorneys for the parties hereto, that the prescribed time within which Defendant may reply to Plaintiff's Opposition to Defendant's Motion to Dismiss for Lack of Personal Jurisdiction is extended to May 23, 2016.
