Plaintiff, a state prisoner, proceeds with a pro se civil rights complaint. The Court previously ordered service on Dr. Rasheed Karim, an ophthalmology surgeon and private contractor for CDCR, and Dr. M. Frazee and Dr. F. Von Lintig.
