Fox Factory, Inc. v. SRAM, LLC

On July 18, 2016, the Court entered a stipulated Order to relate *FOX Factory, Inc. v. SRAM*, *LLC*, Case Nos. 3:16-cv-00506-WHO and 5:16-cv-03716-WHA (now -WHO), which contained a stipulated case schedule to synchronize dates in both cases through claim construction. Dkt. 35 (Case No. 3:16-cv-00506-WHO). In that stipulation, the parties respectfully suggested that a Case Management Conference be set "in the next few weeks" to schedule further dates for fact discovery, expert discovery, dispositive motions, and trial. *Id.* at 1. Although the parties were anticipating a CMC in approximately August 2016, the Court set the next CMC for August 22, 20<u>17</u>. The parties agree that, with the Court's permission, it would be beneficial to convene an earlier CMC in both cases to discuss a mediation schedule and to set dates for fact discovery, expert discovery, dispositive motions, and trial.

Accordingly, the parties HEREBY STIPULATE AND JOINTLY REQUEST that the Court set a CMC on **August 23 or 30, 2016, or September 20, 2016,** when counsel for both parties are available, and that counsel will file a joint case management conference statement at least seven days before the CMC.
