

12 judgment, on or before September 27, 2017;
 - 13 ○ Plaintiffs shall file their opposition to Federal Defendants' and Defendant-
14 Intervenors' summary judgment motions and reply in support of Plaintiffs' motion for
15 summary judgment on or before October 27, 2017;
 - 16 ○ Federal Defendants and Intervenors shall file their replies in support of their cross-
17 motions for summary judgment on Plaintiffs' claims on or before December 7, 2017
- 18 • The hearing is continued from October 20, 2017 to January 19, 2018, at 9:00 A.M.
