REVISING THE COURT'S SCHEDULING
ORDER**

1 **TO THE COURT AND ALL PARTIES AND THEIR ATTORNEYS OF RECORD:**

2 This stipulation to revise the Court's June 30, 2016 Scheduling Order (Dkt. 16) in the
3 above-referenced matter is made and entered into by and between plaintiff Jacquelyn Delaney and
4 defendant State Farm Mutual Automobile Insurance Company ("State Farm"), referred to
5 collectively as the "Parties."

6 **I.**
7 **RECITALS**

8 1. WHEREAS, on June 30, 2016, the Court issued its Scheduling Order (Dkt. 16),
9 setting deadlines for fact discovery, expert discovery, and dispositive motions. The Scheduling
10 Order set June 7, 2017, as the fact discovery cutoff and August 25, 2017, as the expert discovery
11 cutoff.

12 2. WHEREAS, the Parties have not sought any prior extensions to the Court's June 30,
13 2016 Scheduling Order.

14 3. WHEREAS, the Parties desire to submit this matter to mediation.

15 4. WHEREAS, counsel for Delaney and State Farm have engaged in discussions to set
16 the parameters for a possible settlement.

17 5. WHEREAS, the Parties believe that mediation would be more productive and more
18 likely to settle the case if the Parties have additional time to conduct discovery and assess the merits
19 of the case prior to the mediation.

20 6. WHEREAS, the Parties do not seek any extension of dates currently set by the
21 Scheduling Order except for the fact discovery cutoff, expert disclosures, and expert discovery
22 cutoff.

23 7. WHEREAS, the Parties have been working diligently toward moving this case
24 forward in an efficient, expeditious manner. The Parties wish to litigate this matter in a cost-
25 effective manner and avoid unnecessary attorneys' fees and costs.

26 8. WHEREAS, the Parties have tentatively agreed to hold the mediation session by
27 June 30, 2017, subject to the Court's approval.

28 9. WHEREAS, the Parties have agreed to submit this Stipulation and [Proposed] Order

1 to Revise the Court's Scheduling Order.

2 10. WHEREAS, the Parties hereby stipulate to revising the Court's June 30, 2016
3 Scheduling Order as follows.
