Brian Moffitt, an inmate at Salinas Valley State Prison, filed this pro se action for a writ of habeas corpus pursuant to 28 U.S.C. § 2254. He states that he is challenging a sentence from the Amador County Superior Court, and alleges that his continued incarceration is past the end of his 3-year maximum incarceration under California Penal Code § 1370. (ECF No. 1 at 5.) He consented to proceed before a magistrate judge. (ECF No. 7.) Mr. Moffitt is incarcerated in Monterey County, which is located within the venue of the Northern District of California, and his conviction occurred in Amador County, which is located within the venue of the Eastern District of California. Venue is proper in a habeas action in either the district of confinement or the district of conviction, with the preferable district being the district of conviction for a petition challenging
