**JOINT STIPULATION AND
 [PROPOSED] ORDER FOR
 REFERRAL TO MAGISTRATE
 JUDGE FOR SETTLEMENT
 CONFERENCE**

1 Plaintiffs MICHELE SMITH, acting on her own behalf and as Guardian ad Litem for
2 M.M., (“Plaintiffs”) and Defendants TOBINWORLD, SARA FORGHANI, ANDREW ALTES,
3 and ANTIOCH UNIFIED SCHOOL DISTRICT (hereinafter “AUSD”), through their undersigned
4 counsel, hereby stipulate as follows:

5 WHEREAS, counsel for Plaintiffs and the counsel for Defendants AUSD, SARAH
6 FORGHANI, and TOBINWORLD are also involved in a similar case currently pending in the U.S.
7 District Court for the Northern District of California entitled *Calloway, et al. v. Oakland Unified*
8 *School District, et al.*, USDC Case No. 3:16-cv-6942-CRB (hereinafter the “*Calloway matter*”);

9 WHEREAS, all parties wish to schedule a settlement conference before a Magistrate Judge
10 wherein both this matter and the *Calloway matter* may be mediated together;

11 WHEREAS, in the *Calloway matter*, on April 7, 2017, the court issued a minute order
12 directing counsel to submit a stipulation and proposed order referring both *Calloway matter* and the
13 instant case to a Magistrate Judge for a settlement conference (Doc No. 55);

14 WHEREAS, the parties have met and conferred by email and have agreed that they would
15 like to participate in a settlement conference before Magistrate Judge Jacqueline Scott Corley;

16 Thus, the parties jointly respectfully request that the Court refer this matter to a settlement
17 conference before a Magistrate Judge Corley wherein the parties may also discuss settlement of the
18 *Calloway matter*.
