5	July 12, 2018: Last day Plaintiff to file its Reply Brief		
6	4. Pursuant to the arbitration award, the arbitrator ordered Defendant to provide certain		
7	calculations to Plaintiff concerning the Parties' Reinsurance Participation Agreement, which is the		
8	subject of this action. During the CMC, the Court advised the Parties that if Defendant needed		
9	additional time beyond June 21, 2018 to provide the calculations to Plaintiff, the Parties could		
10	notify the Court of the same and request a continuance of the hearing on the Motion.		
11	5. As of today, Defendant needs additional time to provide the calculations to Plaintiff		
12	Therefore, the Parties request that the hearing and briefing schedule be continued for at least anothe		
13	30 days.

15	The Parties hereby stipulate pursuant to Civil Local Rule 7-12 that the hearing on Plaintiff'
