1 WHEREAS, on April 18, 2016, plaintiff Securities and Exchange Commission
2 (“Plaintiff”) filed a complaint in the above-captioned action (the “Complaint”) asserting claims
3 against defendants Erik K. Bardman and Jennifer F. Wolf (“Defendants” and, together with
4 Plaintiff, the “Parties”);

5 WHEREAS, Defendants filed motions to dismiss the Complaint (ECF Nos. 16-18),
6 which were originally set to be heard on September 29, 2016, but the hearing has been rescheduled
7 for October 18, 2016 (ECF No. 20);

8 WHEREAS, the Parties previously stipulated, and the Court ordered, that the Case
9 Management Conference would be set for October 12, 2016, approximately two weeks after the
10 original hearing date for Defendants’ motions to dismiss (ECF No. 8); and

12 the hearing on Defendants’ motions to dismiss to October 18, 2016, to also reschedule the Case
13 Management Conference accordingly.

15 Plaintiff and the attorneys for Defendants, as follows:

16 1. The Case Management Conference currently set for October 12, 2016 is
17 rescheduled for ~~November 2, 2016 at 2:00 p.m.~~ November 9, 2016 at 2:00 p.m.
