1 WHEREAS, on April 18, 2016, plaintiff Securities and Exchange Commission
2 (“Plaintiff”) filed a complaint in the above-captioned action (the “Complaint”) asserting claims

4 Plaintiff, the “Parties”);

5 WHEREAS, the Parties have agreed that Defendants will accept service of the

18 3. In the event that Defendants file one or more motions to dismiss the
19 Complaint, Plaintiff’s opposition to any motions to dismiss shall be filed on or before August 25,
20 2016.

21 4. Defendants’ reply briefs in support of any motions to dismiss the Complaint
22 shall be filed on or before September 15, 2016.

23 5. The hearing on Defendants’ motions to dismiss the Complaint, if any, shall
24 be set for September 29, 2016 at 2:00 p.m.

25 6. The Case Management Conference currently set for July 20, 2016 is
26 rescheduled for October 12, 2016 at 2:00 p.m.

27 There have been no requests for an extension of time previously made in this matter.
