12 motions Defendants may file in response to the complaint in lieu of an answer:

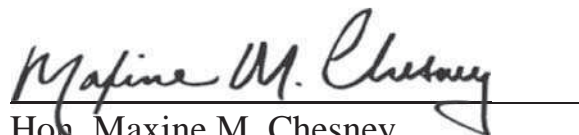
