1 Pursuant to Local Rule 6-2, Plaintiff Ultratech, Inc. (“Ultratech”) and  
2 Defendant Analog Devices, Inc. (“ADI”) (collectively, the “Parties”) submit this  
3 stipulation to continue the hearing date on the Parties’ respective Motions to Enforce  
4 Settlement Agreement from July 15, 2016 to July 22, 2016.

5 WHEREAS, Ultratech filed the Complaint in this action on May 3, 2016 in the  
6 Northern District of California;

7 WHEREAS, the Parties executed a settlement agreement on May 20, 2016;

8 WHEREAS, ADI filed a Motion to Enforce Settlement Agreement, Dismiss  
9 the Complaint, and Award Attorney’s Fees on June 7, 2016 (Dkt. 12);

17 date, including a concurrent trial in the Southern District of New York and binding  
18 personal obligations;

19 WHEREAS, Ultratech and ADI have mutually agreed to continue the hearing  
20 date on the Parties’ motions to July 22, 2016, and

21 WHEREAS, there have been no previous time modifications relating to this  
22 hearing, and the requested time modification would not affect the remaining schedule  
23 for this case;
