**ORDER NO. 2 TO SUBMIT  
SUPPLEMENTAL BRIEFING IN  
SUPPORT OF MOTION FOR DEFAULT  
JUDGMENT**

Re: Dkt. No. 18

11 On September 27, 2016, Plaintiffs Operating Engineers Health and Welfare Trust Fund for  
12 Northern California et al. ("Plaintiffs") filed a motion for default judgment. [Docket No. 18.]

13 Having reviewed that motion, this court determines that Plaintiff did not brief its entitlement to the  
14 entry of default judgment pursuant to the factors enumerated in the Ninth Circuit's decision in  
15 *Eitel v. McCool*, 782 F.2d 1470, 1471-72 (9th Cir. 1986).

16 Further, in order to recover damages after securing a default judgment, a plaintiff must  
17 prove the relief it seeks by submitting proper evidence by way of a sworn affidavit. *Bd. of Trs. of*  
18 *the Boilermaker Vacation Trust v. Skelly, Inc.*, 389 F. Supp. 2d 1222, 1226 (N.D. Cal. 2005); see  
19 *Pepsico, Inc. v. Cal. Sec. Cans*, 238 F. Supp. 2d 1172, 1175 (C.D. Cal. 2002) (citing *Televideo*  
20 *Sys., Inc. v. Heidenthal*, 826 F.2d 915, 917-18 (9th Cir. 1987)).

21 Here, Plaintiff lists the amounts of unpaid and late-paid contributions on page 2 of its  
22 motion, but does not attach documents or reports to the Declaration of David E. Hayner showing  
23 how it arrived at those amounts. See Hayner Decl., ¶ 20.

24 Plaintiff shall submit additional briefing by **NOVEMBER 7, 2016**, to address the above  
25 deficiencies in the motion for default judgment, and shall serve Defendant with any briefing or any  
26 additional submissions.
