ORDER DENYING PLAINTIFF'S TIONS TO INTERPLEAD AND FOR PROMISSORY NOTE

Re: Dkt. Nos. 39, 41

Plaintiff is a California prisoner proceeding pro se who filed this civil rights case under 42 U.S.C. § 1983. Plaintiff's motion for summary judgment and Defendant's motion for judgment on the pleadings are under submission. Plaintiff has filed a motion to interplead "Defendant(s)" in which he moves for "Defendant(s) to be Ordered to Interplead and Settle among themselves their rights" to his prison trust account. This request does not make sense in the context of this case in which there is only one Defendant. In addition, Plaintiff appears to believe that this request is necessary in light of contradictions between his summary judgment papers and Defendant's waiver of reply. It is not. Disputes between Plaintiff and Defendant will be ruled upon when the summary judgment and motion for judgment on the pleadings are resolved. Plaintiff has also filed a motion for the Clerk of Court to pay a promissory note for an "appearance bond" to ensure his appearance in court. There is no authority or necessity to require the Clerk do so. Plaintiff's motions are DENIED.

This Order disposes of Docket Nos. 39 and 41.
