1 Pursuant to Civil L.R. 6-2, the parties hereby request an order moving the initial CMC
2 from October 12, 2016, to October 19, 2016, or another date subject to the Court's convenience,
3 as October 12, 2016, is the religious holiday of Yom Kippur, which C&A Marketing's lead
4 counsel and inside counsel both observe.

5 The parties previously stipulated to a 15-day extension of time for Defendants to respond


