1 Pursuant to Local Rules 7-12 and 16-2(d) and Judge Orrick’s Standing Case Management
2 Conference Order, Plaintiff Exeter Finance Corp. (“Plaintiff”) and Defendant Autocom Energy,
3 LLC d/b/a Autocom Nissan of Concord (“Defendant”) (collectively, the “Parties”) hereby
4 respectfully stipulate and jointly request that the Court continue the Case Management Conference
5 and related deadlines as follows:

6 RECITALS

7 1. Plaintiff’s Complaint was filed in the United States District Court, Northern District
8 of California on July 25, 2016. (Dkt. 1.)

9 2. The Parties are scheduled to participate in an ADR Telephone Conference on
10 October 18, 2016. (Dkt. 12.)

11 3. Pursuant to the Court’s current Orders (Dkts. 6 and 15), multiple deadlines are set
12 for October 18 and 25, 2016.

13 4. Pursuant to the Court’s recent Order (Dkt. 15), the Initial Case Management
14 Conference is scheduled to take place on November 1, 2016.

15 5. The Parties are engaged in settlement negotiations and wish to continue those
16 discussions during and following their ADR Telephone Conference on October 18, 2016 in order
17 to pursue resolution of this case prior to commencing initial discovery and litigation, and in
18 advance of the Case Management Conference.

19 6. Neither Party has requested any extensions or modifications to the Case
20 Management Conference or related deadlines in the case.

21 7. Pursuant to the foregoing, good cause exists to continue the Case Management
22 Conference and all related deadlines. Therefore, the Parties hereby stipulate and agree to the
23 following extensions, and request the Court’s approval of their stipulation, to the proposed case
24 management schedule as follows:
