Plaintiffs ICE Consulting, Inc. ("ICE"), Uzair Sattar ("Sattar"), and Derick Needham ("Needham"), and Defendant Gavin Jensen ("Jensen"), by and through their respective counsel, hereby enter into this Stipulation to continue the hearing on Plaintiff ICE's Motion for a Preliminary Injunction and Order to Show Cause, currently set for hearing on August 18, 2016. submit any opposition to the Motion by August 12, 2016, and Plaintiff ICE was to submit any reply
papers by August 15, 2016;

WHEREAS, Defendant Jensen only retained counsel on August 16, 2016, and was unable to
submit an opposition by the time specified by the Court; and

WHEREAS, the parties have met and conferred and agree that the August 18, 2016 hearing
should be continued so that Defendant Jensen's counsel may have time to prepare for any hearing on
this matter, and submit an opposition;
