21 **STIPULATION TO CONTINUE CASE MANAGEMENT CONFERENCE**

22 The parties, through undersigned counsel, stipulate as follows:

- 23 1. This matter was filed on October 24, 2017.
- 24 2. Defendant Rosas Brothers Construction, Inc. was served on January 13, 2017. The
 25 three individual defendants have not yet been served.
- 26 3. This matter was assigned to the Hon. Jon S. Tigar effective January 20, 2017,
 27 following plaintiff’s declination to consent to jurisdiction of a magistrate judge for all purposes.
- 28 4. Counsel for defendants was first retained on February 9, 2017. The individual

1 defendants will shortly acknowledge receipt of summons as requested by plaintiff's counsel on
2 February 13, 2017.

3 5. Given the short amount of time between the appearance of defendants and their
4 counsel, the parties respectfully, and jointly, submit that it would be difficult for defendants to
5 engage meaningfully in meet and confer regarding the case, and prepare to exchange initial
6 disclosures, prior to the March 8, 2107 case management conference previously scheduled in this
7 matter.

8 6. In addition, defendants' counsel is on a previously scheduled vacation out of state
9 that will not conclude until February 28, 2017, making it significantly inconvenient for
10 defendants counsel to prepare for and meaningfully participate in the scheduled case management
11 conference.

12 7. Accordingly, the parties respectfully, and jointly, request that the Court continue
13 the case management previously set for March 8, 2017, to a date not less than 90 days thereafter.
