**STIPULATION AND ~~[PROPOSED]~~
 ORDER TO CONTINUE MEDIATION
 DEADLINE AND CASE MANAGEMENT
 CONFERENCE**

1 Pursuant to Northern District Local Rules 6-1(b) and 6-2, Plaintiffs Andre Scott, Ken
2 Fassler, and Elijah Maxwell-Wilson (“Plaintiffs”) and Defendant Comcast Cable
3 Communications Management, LLC (“Comcast”) (collectively, “the Parties”), by and through
4 their respective counsel of record, stipulate to continue the mediation completion deadline and
5 Case Management Conference currently set for August 1, 2017 and August 10, 2017,
6 respectively. Good cause exists for such continuance based upon the following, to which the
7 Parties have met and conferred and agreed:

8 WHEREAS, on March 2, 2017 (ECF No. 30), the Court issued Civil Minutes setting an
9 August 10, 2017 Case Management Conference and an August 1, 2017 mediation completion
10 deadline;

11 WHEREAS, the parties have exchanged initial discovery;

12 WHEREAS, since June, Plaintiffs have been evaluating Comcast’s discovery responses
13 and Comcast’s initial 2,411 page document production;

14 WHEREAS, Plaintiffs are still in the process of reaching decisions regarding the scope of
15 mediation;

16 WHEREAS, Plaintiffs have not agreed to use any of the mediators proposed by Comcast,
17 and therefore the Parties are still in the process of selecting a mediator;

18 WHEREAS, the Parties believe that there is good cause to continue the mediation
19 deadline from August 1, 2017 to August 25, 2017 to explore resolution of this case. The Parties
20 further agree it would be more efficient and productive to continue the Case Management
21 Conference to from August 10, 2017 to September 7, 2017 to allow the parties time to explore
22 resolution of this case.

23 WHEREAS, the Parties have not made any prior requests to continue court-ordered
24 deadlines in this case;

25 WHEREAS, the Parties previously stipulated to extend Defendant’s deadline to file its
26 responsive pleading to Plaintiffs’ Complaint and First Amended Complaint (See Docket Nos. 6,
27 16, 24);

1 WHEREAS, the requested continuances will not otherwise affect this case's schedule;
2 THEREFORE, the Parties hereby stipulate and request that the Court continue the
3 mediation completion deadline from August 1, 2017 to August 25, 2017, and the Case
4 Management Conference from August 10, 2017 to September ¹⁴7, 2017, or a date after September
5 7, 2017 that is convenient for the Court. The parties will file their joint statement at least seven
6 (7) days before the scheduled conference.


[PROPOSED] ORDER
