**JOINT STIPULATION TO AMEND  
 CASE SCHEDULE; [PROPOSED]  
 ORDER**

1 Plaintiff Asetek Danmark A/S (“Asetek”) and Defendants Newegg Inc. and Newegg North  
 2 America Inc. (“Newegg”) jointly stipulate, with the Court’s permission, to amend the Case Schedule  
 3 (Dkt. 38), as provided in the table below. This stipulation (if granted) will not affect the Court’s  
 4 previously scheduled claim construction hearing date, but only intervening dates that should not  
 5 affect the Court.

6 The patents-in-suit (U.S. Patent Nos. 8,240,362 and 8,245,764) are the same as the patents-  
 7 in-suit in *Asia Vital Components Co. Ltd. v. Asetek Danmark A/S*, Case No. 3:16-cv-07160-JST (“the  
 8 *AVC Case*”). The claim construction hearing for both the *AVC Case* and this case are set for the  
 9 same date and time, November 7, 2017 at 1:30 p.m.

10 Counsel for the parties to this action continue to engage in informal settlement discussions,  
 11 and a settlement conference with Magistrate Judge Kim is calendared for July 11, 2017. In view of  
 12 these ongoing settlement discussions, and mindful of the Court’s recent order in the *AVC Case*  
 13 granting AVC a one-month extension until June 30, 2017 to serve invalidity contentions (and  
 14 making additional scheduling modifications that do not affect the claim construction hearing date),  
 15 the parties stipulate and respectfully request that the Court similarly amend the schedule in this case  
 16 as provided in the table below:


