2 **[PROPOSED] ORDER GRANTING APPLICATION**
3 **FOR APPOINTMENT PURSUANT TO 28 U.S.C. ' 1782**

4 Pending before the Court is an application submitted by the United States Attorney, on behalf of
5 the Federal Court of First Instance No. 2 of Mendoza, Argentina, for an order of the Court pursuant to
6 28 U.S.C. § 1782. The United States Attorney requests that the Court appoint Mark R. Conrad,
7 Assistant United States Attorney, as Commissioner and authorize AUSA Conrad to obtain records
8 and/or information and/or testimony from Intel Corporation, as successor to McAfee, Inc., in conformity
9 with the Letters Rogatory issued by the Argentinian Court on November 6, 2014, in connection with the
10 litigation matter captioned *Flowserve S.R.L. v. AFIP-DGI*.

11 The Court has reviewed the documents supporting this request for international judicial
12 assistance as attached to the Declaration of Mark R. Conrad, the application of the United States and
13 memorandum in support thereof, and is informed of the grounds upon which the Letters Rogatory and
14 application are based.

15 Pursuant to the power conferred on it under 28 U.S.C. § 1782, the Court hereby ORDERS that
16 AUSA Mark R. Conrad is appointed as Commissioner, that AUSA Conrad is authorized to issue
17 subpoenas to obtain the records and/or information and/or testimony from Intel Corporation, as
18 successor to McAfee, Inc., in compliance with the Letters Rogatory, and that AUSA Conrad is
19 authorized to take all steps reasonably necessary for the accomplishment of the Letters Rogatory and the
20 fulfillment of the request of the Federal Court of First Instance No. 2 of Mendoza, Argentina.
