26 Plaintiffs and Defendant herein respectfully submit this Joint Request to Continue the Case
27 Management Conference, currently on calendar for May 9, 2017, for approximately sixty to ninety (60-

1 90) days. Good cause exists for the granting of the continuance, as follows:

2 1. As the Court's records will reflect, this action was filed on February 1, 2017 (Dkt. #1).
3 Thereafter, the Court issued an order (Dkt. #11) finding that this action is related to the following case:
4 *Northern California Glaziers, Architectural Metal and Glass Workers Pension Trust Fund, et al. v.*
5 *SOTD Corporation dba The Glass Man & Sons* (U.S.D.C. Case No. 17-cv-00518-WHO). Defendant
6 filed a Notice of Appearance of Counsel (Dkt. #13) on March 27, 2017, and the parties entered into a
7 stipulation to extend Defendant's deadline to answer or otherwise respond to the Complaint from March
8 30, 2017 to May 1, 2017 (Dkt. #14).

9 2. Since then, the parties have been in contact to attempt to resolve this matter without the
10 need for further litigation, and regarding selection of an ADR Process, as required by the Court.

11 3. The parties entered into a second stipulation to extend Defendant's deadline to answer or
12 otherwise respond to the Complaint from May 1, 2017 to May 31, 2017 which is being filed
13 concurrently with this Joint Request to Continue. The parties believe that this additional time will assist
14 in their attempts to resolve the matter without the need for further litigation.

15 4. Based on the above, the parties respectfully request that the Case Management
16 Conference, currently scheduled for May 9, 2017, be continued for approximately sixty to ninety (60-
17 90) days to allow sufficient time for the parties to meet and confer regarding determine whether this
18 matter can be resolved without the need for further litigation.
