**JOINT STIPULATION AND
ORDER TO EXTEND TIME TO
FILE REPLY IN SUPPORT OF
MOTION FOR LEAVE TO FILE
AMENDED COUNTERCLAIMS**

CIVIL L.R. 6-1

1 Pursuant to Civil Local Rule 6-1(a), it is hereby stipulated by and between Plaintiff
2 Synopsys, Inc. (“Synopsys”) and Defendant Ubiquiti Networks, Inc. (“Ubiquiti”), through
3 respective counsel, as follows:

4 1. On September 19, 2017, Ubiquiti filed its Motion for Leave to file Amended
5 Counterclaims, requesting a hearing before the Court on November 1, 2017 (Dkt. No. 77), and on
6 October 3, 2017, Synopsys filed its brief in opposition (Dk. No. 78).

7 2. On October 4, 2017, the Court issued a notice resetting the hearing date for
8 Ubiquiti’s motion to November 8, 2017.

9 3. Pursuant to Local Rule 7-3(c), Ubiquiti’s deadline to file a reply brief in support of
10 its motion is October 10, 2017.

11 4. Due to evacuations from the fires in Napa and Sonoma Counties, members of the
12 case team at Ubiquiti’s outside counsel are unavailable to finalize the reply brief on October 10,
13 2017.

14 5. Because of ongoing uncertainty as to fire evacuations, Counsel for Synopsys and
15 Ubiquiti agree that it is appropriate to extend Ubiquiti’s last day to file a reply brief in support of
16 its motion from October 10, 2017 to October 13, 2017.

17 6. The Parties have made the following prior requests for extensions in this case.

18 7. On February 22, 2017, the Parties filed a Joint Stipulation to Extend Time to
19 Respond to Complaint, extending the deadline to March 7, 2017.

20 8. On August 25, 2017, the Parties filed a Joint Stipulation to Extend Time to
21 Respond to Amended Complaint, extending that deadline from September 4, 2017 to fourteen
22 (14) days from the date that Plaintiff filed a further amended complaint, or fourteen (14) days
23 from September 4, whichever date is earlier.

24 9. On September 11, 2017, recognizing that due to the Labor Day holiday the parties
25 had misidentified Plaintiff’s last day to file a further amended complaint as September 4, 2017,
26 and because Plaintiff filed a further amended complaint on September 5, 2017, the Parties filed a
27 Joint Stipulation to Extend Time to Respond to Amended Complaint from September 18, 2017 to
28 September 19, 2017.


