**ORDER (1) GRANTING MOTION TO
WITHDRAW AND (2) TO SHOW
CAUSE WHY MR. PEKEL'S CASE
SHOULD NOT BE DISMISSED BASED
ON HIS FAILURE TO PROSECUTE IT**

Re: ECF No. 69

INTRODUCTION

The plaintiffs — on behalf of a national class and California and Florida subclasses — sue Ygrene Energy for fraud relating to home-improvement loans.¹ Plaintiffs' counsel move to withdraw only as to Michael G. Pekel because they have been unable to contact him since September 2017.² The defendants do not object to the motion to withdraw.³

The court grants the motion to withdraw and directs plaintiffs' counsel to continue to accept service of all filings and serve them on Mr. Pekel. The court also orders Mr. Pekel to appear in person or through counsel at 450 Golden Gate Avenue, 15th Floor, Courtroom C, San Francisco,

1 California, on February 8, 2018, at 11:00 a.m., to show cause why the court should not dismiss his
2 case for his failure to prosecute it.

3
4 **STATEMENT**

5 On September 27, 2017, Plaintiffs’ counsel Manuel Hiraldo sent an email to Mr. Pekel to
6 schedule his deposition.⁴ “That same day, Mr. Pekel responded that he was available during the
7 proposed date and time.”⁵ On October 4, 2017, Mr. Hiraldo “emailed a copy of the notice of
8 deposition to Mr. Pekel” and asked him to confirm receipt.⁶ Mr. Hiraldo did not receive a
9 response.⁷ Mr. Hiraldo followed up with Mr. Pekel via email on October 9, October 18, and
10 October 26, 2017.⁸ He attempted to contact Mr. Pekel on his cell phone.⁹ He also contacted Mr.
11 Pekel via text message on October 11, October 18, October 23, October 26, and October 27,
12 2017.¹⁰ Mr. Pekel did not respond to the e-mails, calls, or text messages.¹¹ As a result of Mr.
13 Pekel’s unresponsiveness, plaintiffs’ counsel has been unable to schedule Mr. Pekel’s deposition
14 with the defendants’ counsel.¹²

15 On November 2, 2017, Mr. Hiraldo sent a letter to Mr. Perkel’s last known address “regarding
16 whether he wished to continue perusing his claims, and [Mr. Hiraldo’s] intent to terminate [the]
17 attorney-client relationship if he did not respond.”¹³ He also sent a copy of the letter via email.¹⁴
18 Mr. Pekel did not respond.¹⁵

1 At the motion-to-dismiss hearing on November 2, 2017, plaintiffs’ counsel first raised their
2 communication issues with Mr. Pekel.¹⁶ The court also discussed the issue with the parties at the
3 case-management conference on December 14, 2017.¹⁷ The court set a further case-management
4 conference for January 18, 2018, where counsel discussed their continued efforts to contact Mr.
5 Pekel.

6 On January 9, 2018, plaintiffs’ counsel moved to withdraw as counsel for Mr. Pekel.¹⁸
7 Plaintiffs’ counsel served Mr. Pekel with a copy of the motion.¹⁹ The court granted the motion to
8 withdraw on the record and issues this order to document that decision and to schedule next steps,
9 including its order to Mr. Pekel to appear in person or through counsel on February 8, 2018 at
10 11:00 a.m. and show cause why his case should not be dismissed for his failure to prosecute it.

12 ANALYSIS

13 1. Motion to Withdraw

14 Under Civil Local Rule 11-5(a), “[c]ounsel may not withdraw from an action until relieved by
15 order of Court after written notice has been given reasonably in advance to the client and to all
16 other parties who have appeared in the case.” Until the client obtains other representation, motions
17 to withdraw as counsel may be granted on the condition that current counsel continue to serve on
18 the client all papers from the court and from the opposing parties. Civil L.R. 11-5(b).

19 Withdrawal is governed by the California Rules of Professional Conduct. *See Nehad v.*
20 *Mukasey*, 535 F.3d 962, 970 (9th Cir. 2008) (applying California Rules of Professional Conduct to
21 attorney withdrawal); *see also Dieter v. Regents of Univ. of Cal.*, 963 F. Supp. 908, 910 (E.D. Cal.
22 1997). Under California Rule of Professional Conduct 3-700(C), counsel may withdraw if the
23 client makes it unreasonably difficult for the attorney to carry out his or her duties. Cal. R. Prof.
24 Conduct 3-700(C)(1)(d).

1 In compliance with California Rule of Professional Conduct 3-700(A)(2), counsel may not
2 “withdraw from employment until the member has taken reasonable steps to avoid reasonably
3 foreseeable prejudice to the rights of the client.” These steps include: (1) giving due notice to the
4 client; (2) allowing time for employment of other counsel, pursuant to Rule 3-700(D); and
5 (3) complying with applicable laws and rules. Cal. R. P. Conduct 3-700(A)(2); *El Hage v. U.S.*
6 *Sec. Assocs., Inc.*, No. 06-CV-7828-TEH, 2007 WL 4328809, at *1 (N.D. Cal. Dec. 10, 2007).

7 The decision to permit counsel to withdraw is within the sound discretion of the trial court.
8 *United States v. Carter*, 560 F.3d 1107, 1113 (9th Cir. 2009). Courts consider several factors when
9 deciding a motion for withdrawal, including: “(1) the reasons counsel seeks to withdraw; (2) the
10 possible prejudice that withdrawal may cause to other litigants; (3) the harm that withdrawal might
11 cause to the administration of justice; and (4) the extent to which withdrawal will delay resolution
12 of the case.” *Deal v. Countrywide Home Loans*, No. 09-CV-01643-SBA, 2010 WL 3702459, at *2
13 (N.D. Cal. Sept. 15, 2010).

14 Good cause exists for withdrawal. Mr. Pekel has not participated in the case, despite counsels’
15 efforts to contact him. Mr. Pekel’s unresponsiveness makes it “unreasonably difficult” for Mr.
16 Pekel’s counsel to carry out their duties.

17 Moreover, counsel took reasonable steps to avoid prejudice to Mr. Pekel from the withdrawal.
18 They notified him a month before filing the motion to withdraw.²⁰ Counsel served him with a copy
19 of the motion to withdraw.²¹ Withdrawal will not prejudice the other named plaintiffs or putative
20 class members because plaintiffs’ counsel will continue to represent them.

21

22 **2. Further Hearing and Notice to Mr. Pekel**

23 The court orders Mr. Pekel to appear in person or through counsel on February 8, 2018 at 11:00
24 a.m. to show cause why the court should not dismiss his case for his failure to prosecute it. If he
25 does not appear, he risks sanctions, including (1) terminating sanctions in the form of dismissal of

1 his case if he does not appear and participate in his litigation and (2) monetary sanctions. The
2 court sets forth the legal standards to give Mr. Pekel an understanding about what the rules require
3 of him.

4 **2.1 Terminating sanctions**

5 Federal Rules of Civil Procedure 41(b) provides that if the plaintiff fails to prosecute or to
6 comply with these rules or a court order, a defendant may move to dismiss the action or any claim
7 against it. Such an order to dismiss operates as an adjudication on the merits. Fed. R. Civ. P. 41(b).

8 “Rule 41(b) specifically provides that the failure of the plaintiff to prosecute his claim is
9 grounds for involuntary dismissal of the action. The courts have read this rule to require
10 prosecution with ‘reasonable diligence’ if a plaintiff is to avoid dismissal.” *Anderson v. Air W.,*
11 *Inc.*, 542 F.2d 522, 524 (9th Cir. 1976) (citing *Ballew v. Southern Pacific Co.*, 428 F.2d 787 (9th
12 Cir. 1970)). “This court has consistently held that the failure to prosecute diligently is sufficient by
13 itself to justify a dismissal, even in the absence of a showing of actual prejudice to the defendant
14 from the failure.” *Anderson*, 542 F.2d 522 at 524 (internal citation omitted). “The law presumes
15 injury from unreasonable delay.” *Id.* at 524 (citing *States Steamship Co. v. Philippine Air Lines*,
16 426 F.2d 803, 804 (9th Cir. 1970)). “However, this presumption of prejudice is a rebuttable one
17 and if there is a showing that no actual prejudice occurred, that factor should be considered when
18 determining whether the trial court exercised sound discretion.” *Id.* (citing *Reizakis v. Loy*,
19 490 F.2d 1132 (4th Cir. 1974).

20 In *Yourish v. California Amplifier*, the Ninth Circuit applied the same five-factor standard
21 considered in Federal Rules of Civil Procedure 37(b) case in a Rule 41(b) case. 191 F.3d 983 (9th
22 Cir. 1999). “Under our precedents, in order for a court to dismiss a case as a sanction, the district
23 court must consider five factors: ‘(1) the public’s interest in expeditious resolution of litigation;
24 (2) the court’s need to manage its docket; (3) the risk of prejudice to the defendants; (4) the public
25 policy favoring disposition of cases on their merits; and (5) the availability of less drastic
26 alternatives.’” *Yourish*, 191 F.3d 983 at 990 (citing *Hernandez v. City of El Monte*, 138 F.3d 393,
27 399 (9th Cir.1998) (quoting *Henderson v. Duncan*, 779 F.2d 1421, 1423 (9th Cir.1986))). “We
28 ‘may affirm a dismissal where at least four factors support dismissal . . . or where at least three

1 factors ‘strongly’ support dismissal.’” *Id.* (citing *Hernandez*, 138 F.3d at 399 (internal citation
2 omitted)). “Although it is preferred, it is not required that the district court make explicit findings
3 in order to show that it has considered these factors and we may review the record independently
4 to determine if the district court has abused its discretion.” *Id.* (internal citation omitted.) “The
5 sub-parts of the fifth factor are whether the court has considered lesser sanctions, whether it tried
6 them, and whether it warned the recalcitrant party about the possibility of case-dispositive
7 sanctions.” *Connecticut General Life Ins. Co. v. New Images of Beverly Hills*, 482 F.3d 1091,
8 1096 (9th Cir. 2007) (citing *Valley Eng’rs v. Electric Eng’g Co.*, 158 F.3d 1051, 1057 (9th Cir.
9 1998)).²²

10 “A terminating sanction, whether default judgment against a defendant or dismissal of a
11 plaintiff’s action, is very severe.” *Connecticut General Life Ins. Co.*, 482 F.3d at 1096. “Only
12 ‘willfulness, bad faith, and fault’ justify terminating sanctions.” *Id.* (quoting *Jorgensen v.*
13 *Cassiday*, 320 F.3d 906, 912 (9th Cir. 2003)).

14 A party suffers sufficient prejudice to warrant case-dispositive sanctions where the disobedient
15 party’s actions “impair the defendant’s ability to go to trial or threaten to interfere with the rightful
16 decision of the case.” *See in re Phenylpropanolamine (PPA) Prods. Liab. Litig.*, 460 F.3d 1217,
17 1227 (9th Cir. 2006) (quotation omitted).

18 Before ordering a terminating sanction, a court must warn the plaintiff and try other sanctions
19 first. For example, a district court’s failure to warn a party that dismissal is being considered as a
20 sanction weighs heavily against the sanction. *U.S. for Use and Ben. of Wiltec Guam, Inc. v.*

1 *Kahaluu Const. Co., Inc.*, 857 F.2d 600, 605 (9th Cir. 1988). Although “[a]n explicit warning is
2 not always required, at least in a case involving ‘egregious circumstances,’” “[i]n other
3 circumstances, the failure to warn may place the district court’s order in serious jeopardy.” *Id.*
4 (citing *Malone*, 833 F.2d at 132-33). Indeed, “[f]ailure to warn has frequently been a contributing
5 factor in [Ninth Circuit] decisions to reverse orders of dismissal.” *Id.* (quoting *Malone*, 833 F.2d
6 at 133 (citing cases)).

7 **2.2 Monetary sanctions: Federal Rules of Civil Procedure 37(d)(3) and (b)(2)(C)**

8 Rules 37(d)(3) and (b)(2)(C) provide that courts must require the party failing to act, the
9 attorney advising that party, or both to pay to award the reasonable expenses, including attorney's
10 fees, caused by the failure, unless the failure was substantially justified or other circumstances
11 make an award of expenses unjust. “Under Rule 37(b)(2), which has the same language as Rule
12 37(d), the burden of showing substantial justification and special circumstances is on the party
13 being sanctioned.” *Hyde & Drath v. Baker*, 24 F.3d 1162, 1171 (9th Cir. 1994), *as amended* (July
14 25, 1994) (citing *Falstaff Brewing Corp. v. Miller Brewing Co.*, 702 F.2d 770, 784 (9th Cir.1983))

15 Federal courts use the lodestar method to determine a reasonable attorney’s fee award. *Hensley*
16 *v. Eckerhart*, 461 U.S. 424, 433 (1983); *Jordan v. Multnomah Cnty.*, 815 F.2d 1258, 1262 (9th
17 Cir. 1987). The court calculates a “lodestar amount” by multiplying the number of hours counsel
18 reasonably spent on the litigation by a reasonable hourly rate. *See Morales v. City of San Rafael*,
19 96 F.3d 359, 363 (9th Cir. 1996). The burden of proving that claimed rates and number of hours
20 worked are reasonable is on the party seeking the fee award. *Blum v. Stenson*, 465 U.S. 886, 897
21 (1984). The court may adjust the award from the lodestar figure upon consideration of additional
22 factors that may bear upon reasonableness. *Stetson v. Grissom*, 821 F.3d 1157, 1167–68 (9th Cir.
23 2016).

24 **2.3 Order to Appear on February 8, 2018, at 9:30 a.m. and Warning to Mr. Pekel**

25 Because Mr. Pekel has not been communicating with his attorney or otherwise participating in
26 his lawsuit, the court orders him to appear on February 8, 2018, at 11:00 a.m. If he does not, he
27 risks the court’s imposition of sanctions, including a monetary sanction awardable to the
28

1 defendant for any costs that it incurs for Mr. Pekel’s failure to prosecute his case and — because
2 he is not participating in his litigation — dismissal of his case for failure to prosecute it.

3
4 **CONCLUSION**

5 The court grants the motion to withdraw. The court orders plaintiffs’ counsel to continue to
6 serve Mr. Pekel with all papers until Mr. Pekel files a substitution of counsel. *See* Civil L.R. 11-
7 5(b) (“When withdrawal by an attorney from an action is not accompanied by simultaneous
8 appearance of substitute counsel . . . , leave to withdraw may be subject to the condition that papers
9 may continue to be served on counsel for forwarding purposes, unless and until the client appears
10 by other counsel[.]”). Plaintiffs’ counsel must inform Mr. Pekel of this condition. *See id.* (“When
11 this condition is imposed, counsel must notify the party of this condition.”) Specifically, plaintiffs’
12 counsel must serve a copy of this order on Mr. Pekel and file proof of service with the court within
13 one week.

14 The court orders Mr. Pekel to appear in person or through counsel at 450 Golden Gate Avenue,
15 15th Floor, Courtroom C, San Francisco, California, on February 8, 2018, at 11:00 a.m. to show
16 cause why his case should not be dismissed based on his failure to prosecute it.

17 **IT IS SO ORDERED.**
