22 WHEREAS, on October 25, 2017, the Court granted GameStop's motion to compel
23 arbitration as to Brier's first eight claims, dismissing Brier's class claims and staying his
24 representative PAGA claim pending arbitration of Brier's individual claims. Plaintiff GEORGE
25 BRIER and Defendant GAMESTOP CORPORATION (“Defendant”) (collectively, the
26 “Parties”), acting through counsel, and pursuant to Federal Rule of Civil Procedure
27 41(a)(1)(A)(ii), hereby stipulate, in consideration of a negotiated settlement executed by them,
