The week of April 9, 2018, in response to an inquiry from a representative of Defendant, Plaintiffs confirmed the appropriate mailing address for the settlement check. Defendants represent that due to internal financial processing systems, it has taken longer than anticipated to process the settlement check in this matter. Defendant expects to issue and mail the settlement check by early the week of April 23, 2108. Defendant's signatory for the settlement agreement is currently unavailable to sign the settlement agreement, but Defendant expects that the signatory will do so when the signatory returns to the office on April 20, 2018. Defendant respectfully requests a brief extension of the deadlines specified in the Court's March 2, 2018 Order.
