5	application is incomplete because it does not contain a properly completed and signed		
6	Certificate of Funds. Nor does it contain a prison trust account statement that shows the		

transactions for the last six months. Accordingly, the action is DISMISSED without prejudice for failing to respond to the Court's order, and for failure to prosecute, see Fed.

R. Civ. P. 41(b).¹

Because this dismissal is without prejudice, petitioner may move to reopen the 20 action. Any such motion **must** contain the two documents noted above, or full payment 21 for the filing fee of \$5.00. 22

Petitioner's IFP application (Dkt. No. 4) is DENIED as insufficient.
