A court may grant judgment on the pleadings under Rule 12(c) "when the moving party clearly establishes on the face of the pleadings that no material issue of fact remains to be resolved and that it is entitled to judgment as a matter of law." <u>Hal Roach Studios, Inc. v.</u> <u>Richard Feiner & Co.</u>, 896 F.2d 1542, 1550 (9th Cir. 1990) (citation omitted). The Eleventh Amendment bars § 1983 claims against CHP because it is indeed a state agency. <u>See, e.g.</u>, <u>Sims v. Lee et al.</u>, 651 F. App'x 570, 571 (9th Cir. 2016) (affirming district court's dismissal

1 under the Eleventh Amendment of plaintiff's § 1983 claim against CHP).

Accordingly, the Court GRANTS CHP's motion for judgment on the pleadings without oral argument pursuant to Civil Local Rule 7-1(b) and VACATES the motion hearing set for September 1, 2017. That decision of course does not affect Heyward's claims against Officer Hyer. The parties are therefore ORDERED to appear for an initial case management conference on September 1, 2017, at 450 Golden Gate Avenue, 17th Floor, Courtroom 6, at 10:00 a.m.

The Court also DIRECTS Heyward's attention to the Handbook for Pro Se Litigants, which is available on the Court's website located at http://cand.uscourts.gov/proselitigants.
