18 In the above entitled action, the defendant MICHELE D. THOMAS aka MICHELE

3 NOW, THEREFORE, by virtue of the law and by reason of the premises aforesaid,
4 IT IS ADJUDGED that the United States of America, plaintiff, do have and recover of
5 and from the defendant, MICHELE D. THOMAS aka MICHELE THOMAS aka MICHELLE
6 D. THOMAS aka MICHELLE THOMAS, the sum of \$20,499.96 as principal, interest,
7 attorney fees, and costs, plus interest in the amount of \$1.83 per day from July 12, 2017, to
8 the date of entry of the judgment, plus post judgment interest thereafter at the current legal
9 rate per annum, pursuant to the provisions of 28 USC Sec. 1961(a) which will be
