1 WHEREAS, Plaintiffs Julian Fraser, Joseph Wucher, Irene Damsky, Kim Zaia, and Chris
2 Jackson (collectively, "Plaintiffs") filed a Complaint against Defendant Nationwide Mutual
3 Insurance Company on or about June 28, 2017, in the Northern District of California; and

4 WHEREAS, on September 26, 2017, Plaintiffs filed a First Amended Complaint based on the
5 Parties' Joint Stipulation for Leave to File the First Amended Complaint and the Court's Order
6 regarding the same; and

7 WHEREAS, following the Court's November 29, 2017 Order extending the deadline to
8 attend private mediation, from March 21, 2018 to April 2, 2018, and the time for the Parties to file
9 their joint status report to April 12, 2018, and the date of the status conference to April 19, 2018; and

10 WHEREAS, following the Court's November 29, 2017 order extending the deadline to
11 attend private mediation from March 21, 2018 to April 2, 2018, the parties engaged in mediation on
12 April 2, 2018 with Jeffrey Ross;

13 WHEREAS, the Parties are continuing to actively engage in settlement negotiations and
14 believe it would be more efficient and effective to briefly continue the Status Conference to allow
15 the parties time to determine whether they will be able to resolve the matter; and

16 IT IS HEREBY STIPULATED by and between the Parties, through their respective counsel
17 of record herein, that:

- 18 ➤ Subject to the Court's convenience and Order, the deadline to file a joint status report,
19 currently set for April 12, 2018, shall be extended to one week before the continued
20 status conference, so that the parties can inform the Court of the outcome of the
21 mediation and their further negotiations; and
- 22 ➤ Subject to the Court's convenience and Order, the status conference set for April 19,
23 2018, shall be continued to April 26, 2018, at 10:30 a.m.
- 24 ➤ In the event that April 26, 2018, at 10:30 a.m. is not convenient for the Court, and
25 understanding that the Court is unavailable from May 2-9, 2018, the Parties are also
26 available to conduct the status conference on May 10, 2018 at 10:30 a.m.
