15 2017, at 9:30 a.m.;

16 NOW THEREFORE the Parties agree that their proposed briefing schedule on Randstad’s
17 Motion and Plaintiff’s Motion should be adopted, and that the Case Management Conference should be
18 continued pending resolution of Randstad’s Motion to Transfer Venue and Plaintiff’s Motion to
19 Remand.
