- 3. Judgment shall be in favor of Plaintiff, United States of America, and against defendant, BONITA N. NIELSEN aka BONITA NADINE NIELSEN aka BONITA NIELSEN, in the sum of \$17,001.60 consisting of \$15,112.41 in principal, \$1,824.19 interest to October 13, 2017, CIF costs of \$0.00, court costs of \$65.00 and attorney's fees of \$0.00, plus interest at the rate of 2.500% per annum (\$1.035 per day) on principal in the amount of \$15,112.41 from October 13, 2017, up to the date of entry of this Consent Judgment, less any sums tendered toward satisfaction of the obligation during said time period.
- 4. This consent judgment shall bear interest pursuant to the provisions of 28 U.S.C §1961(a) at the legal rate per annum from the date of entry of judgment, which interest will be compounded annually pursuant to the provisions of 28 U.S.C. §1961(b) until paid in full.
