1 **STIPULATION**

2 The parties, by and through their respective attorneys of record, hereby stipulate and agree
3 as follows:

- 5 1. On February 8, 2018, Defendants filed a Motion to Dismiss.
 - 6 2. The parties jointly request that the Court continue the briefing schedule as follows:
 - 7 a) Plaintiff's Opposition will be due on or before March 22, 2018.
 - 8 b) Defendant's Reply will be due on or before April 5, 2018.
 - 9 3. Good cause exists because Plaintiffs have several major deadlines and
10 responsibilities in other pending cases, including filing an opposition to summary judgment in a
11 wrongful death case due in approximately three weeks and expert depositions in a separate
12 wrongful death case that would make it impossible to adequately brief opposition papers to

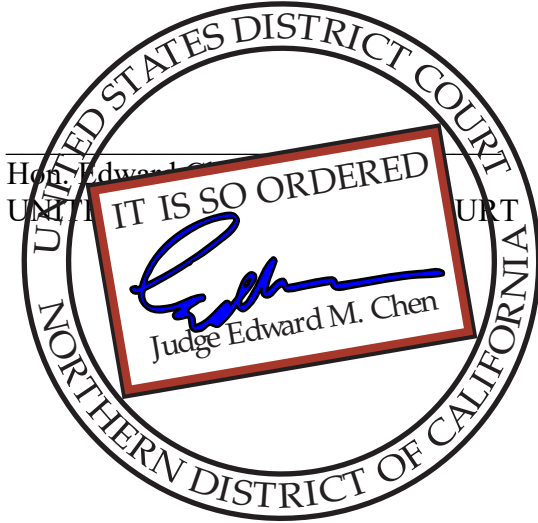
