5 multiple defendants;

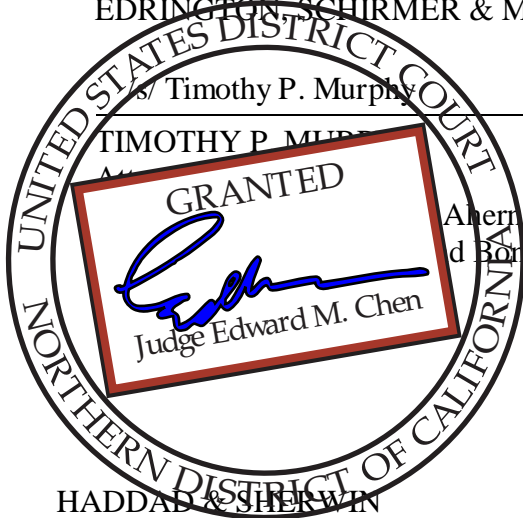
6 IT IS HEREBY STIPULATED, by and between Plaintiffs, Defendants the County of
