This includes: Cal, California, UC Berkeley, UCB, Berkeley Campus, Golden Bears, Oski, etc. The name "Berkeley" can be used only at the end of the student organization's name in reference to a geographical location, i.e., "at Berkeley" or "of Berkeley." The student organization's name may not begin with the word "Berkeley" unless the student organization has received proper authorization from the LEAD Center and/or the office of BCBP.
