**STIPULATION TO CONTINUE  
 OUTSTANDING DEADLINES AND  
 HEARINGS DUE TO SETTLEMENT IN  
 PRINCIPLE; [~~PROPOSED~~] ORDER**

1 Plaintiff Cadence Design Systems, Inc. (“Cadence”) and Defendants Skyworth Digital Holdings  
2 Ltd. (“Skyworth Parent”), Shenzhen Skyworth Automobile Electronics Co. Ltd. (“Skyworth Auto”),  
3 Skyworth Electronic Appliance Ltd. (“Skyworth EA”), Skyworth Electronics Inc. (“SEI”) and Skyworth  
4 USA Corporation (“Skyworth USA”) (collectively the “Parties”) by and through their counsel of record,  
5 hereby stipulate and agree as follows:

6 WHEREAS, on April 25, 2018, Cadence filed its Complaint in this Action;

7 WHEREAS, the Parties’ Joint Case Management Statement and Rule 26(f) Report is due on  
8 August 16, 2018;

9 WHEREAS, the Court has scheduled an initial Case Management Conference and hearings on  
10 SEI’s and Skyworth USA’s motions to dismiss for August 23, 2018;

11 WHEREAS, Cadence’s Opposition to the motion to dismiss filed by Skyworth Parent, Skyworth  
12 Auto, and Skyworth EA (collectively “the Non-US Skyworth Entities”) is due on August 21, 2018, and  
13 the Non-US Skyworth Entities’ Reply is due on August 28, 2018;

14 WHEREAS, the Court has scheduled a hearing on the Non-US Skyworth Entities’ motion for  
15 September 13, 2018;

16 WHEREAS, the Court has ordered the Parties to hold a mediation by November 8, 2018;

17 WHEREAS, the Parties have reached a resolution in principal of their dispute and are in the  
18 process of finalizing their agreement;

19 WHEREAS, the Parties agree that it is in the interest of judicial efficiency to postpone all  
20 outstanding deadlines by roughly 60 days in order to document their settlement in principle;

21 WHEREAS, the Parties agree that the following deadlines shall be continued as follows:

- 22 • Joint Case Management Statement and Rule 26(f) Report: October 15, 2018
- 23 • Initial Case Management Conference and Hearings on SEI’s and Skyworth USA’s
- 24 • Motions to Dismiss: November 15, 2018 at 1:30 P.M.
- 25 • Cadence’s Opposition to Non-US Skyworth Entities’ Motion: October 22, 2018
- 26 • Non-US Skyworth Entities’ Reply: October 29, 2018
- 27 • Hearing on Non-US Skyworth Entities Motion: November 15, 2018 at 1:30 P.M.
- 28 • Deadline to Conduct Mediation: January 7, 2019
