This is a civil rights case brought pro se by a state prisoner. Plaintiff presents allegations regarding an incident that occurred in San Diego County which is located in within the venue of the United States District Court for the Southern District of California. Plaintiff is incarcerated in this district. Because the allegations occurred in the Southern District and the defendants reside there, venue properly lies in that district and not in this one. *See* 28 U.S.C. § 1391(b).<sup>1</sup>

This case is **TRANSFERRED** to the United States District Court for the Southern District of California. *See* 28 U.S.C. § 1406(a). In view of the transfer, the Court will not rule upon plaintiff's motions (Docket Nos. 2, 4) which are **VACATED**.
