1 On October 1, 2019, Plaintiff Raymond McKay and Defendant DoorDash, Inc. filed a Joint  
2 Stipulation pursuant to Civil L.R. 7-12 to reschedule the deadlines for the parties to meet and confer  
3 regarding initial disclosures and to file their Rule 26(f) report until after the Court rules on  
4 Defendant's Motion to Compel Arbitration and Stay Proceedings. The Court hereby GRANTS the  
5 parties' Joint Stipulation, as rescheduling the deadlines will promote efficiency and judicial economy.
