**STIPULATION AND
 ORDER RE FILING OF THIRD
 AMENDED COMPLAINT**

1 Plaintiff International Fur Trade Federation (“IFF”), Defendants City and County of San
2 Francisco and Grant Colfax (together, “Defendants”), and Intervenor-Defendants The Humane Society
3 of the United States and Animal Legal Defense Fund (together, “Intervenors”) (collectively, the
4 “Parties”) hereby stipulate as follows:

5 WHEREAS, in response to IFF’s original complaint in this action (Dkt. 1), Defendants filed a
6 motion to dismiss (Dkt. 15) under both Rules 12(b)(1) and 12(b)(6) in which they argued, *inter alia*,
7 that IFF had not alleged sufficient facts to establish Article III standing;

8 WHEREAS IFF and Defendants thereafter stipulated (Dkt. 23) to IFF’s filing of a first
9 amended complaint (Dkt. 25);

10 WHEREAS Defendants and Intervenors thereafter filed motions to dismiss the first amended
11 complaint (Dkts. 30, 33) solely under Rule 12(b)(6), which motions the Court granted with leave to
12 amend (Dkt. 61);

13 WHEREAS IFF thereafter filed a second amended complaint (Dkt. 62), in response to which
14 Defendants and Intervenors have filed motions to dismiss (Dkts. 67, 70) in which Defendants (but not
15 Intervenors) argue, *inter alia*, that IFF has not alleged sufficient facts to establish Article III standing;

16 WHEREAS, following IFF’s efforts to meet and confer in response to Defendants’ motion, IFF
17 has indicated that it will file a third amended complaint to address Defendants’ argument regarding
18 standing;

19 **NOW, THEREFORE:**

20 1. Pursuant to Rule 15(a)(2), Defendants and Intervenors consent to IFF’s filing of its
21 third amended complaint by September 15, 2020;

22 2. The briefing and hearing schedule previously established by stipulation and Court order
23 (Dkts. 64, 65) regarding Defendants’ and Intervenors’ motions to dismiss and IFF’s motion for
24 summary judgment on the second amended complaint (and the motions themselves) will be rendered
25 moot upon the filing of IFF’s third amended complaint; and

26 3. Within the time for Defendants and Intervenors to respond to the third amended
27 complaint, the Parties will submit a stipulation and proposed order establishing a briefing and hearing

1 schedule regarding Defendants' and Intervenors' anticipated motions to dismiss and IFF's motion for
2 summary judgment on the third amended complaint.
