1 **TO THE COURT, ALL PARTIES, AND THEIR ATTORNEYS OF RECORD:**

2 Plaintiff Daniel Brown (“Plaintiff”) and Defendant New Zealand Trade & Enterprise
3 (“NZTE”) (Plaintiff and Defendant referred to collectively herein as “the Parties”) through their
4 counsels of record, hereby stipulate and agree as follows:

5 WHEREAS, a Joint Case Management Conference statement is due on November 7, 2024;

6 WHEREAS, as an Initial Case Management Conference is set to take place on November 14,
7 2024;

8 WHEREAS, the Parties are scheduled to participate in mediation with Claudia Viera, Esq. on
9 November 19, 2024;

10 WHEREAS, the Parties agree that it will conserve judicial and party resources and promote
11 the orderly administration of justice for the Court to continue the Initial Management Conference
