**[PROPOSED] ORDER DIRECTING
ADDITIONAL INTERIM PAYMENT OF
COSTS**

20 On June 11, 2007, the Court directed Defendants to deposit the sum of \$100,000 with the
21 Clerk of the Court as an interim payment of costs, to provide funds for compensation of the Court
22 appointed expert in this case. Since then, additional sums of \$100,000 have been periodically
23 deposited into the account when it becomes low in funds. The account was last replenished on
24 June 4, 2014, and because of subsequent monthly payments to the expert, Ed Swanson, it is now
25 substantially depleted. Accordingly, Defendants are ordered to deposit forthwith an additional
