 18 On July 8, 2010, Kalitta Air, L.L.C. filed its Motion to Adjourn Trial and set the hearing
 19 on that Motion for Thursday, August 12, 2010. In an effort to expedite the Court's consideration
 20 of the Motion to Adjourn Trial, the parties stipulated to shortening the time for hearing on
 21 Kalitta's Motion and requesting that this Court hear the Motion on August 5, 2010. A
 22 Stipulation and [Proposed] Order Shortening Time for Hearing on Kalitta's Motion to Adjourn
