STIPULATION AND ~~PROPOSED~~ ORDER

 19 IT IS HEREBY STIPULATED by and between the parties, through their undersigned counsel,  
 20 subject to the Court's approval, that counsel for Plaintiff be awarded attorney fees under the Equal  
 21 Access to Justice Act, (EAJA) in the amount of THREE THOUSAND SEVEN HUNDRED AND  
 22 FORTY FOUR DOLLARS (\$3,744.00). This amount represents compensation for all legal services  
 23 rendered on behalf of Plaintiff by the attorney in connection with this civil action in accordance with 28  
 24 U.S.C. § 2412(d).

25 This stipulation does not constitute an admission of liability on the part of Defendant under the  
 26 EAJA. Payment of the agreed upon amounts shall constitute a complete release from and bar to any and  
 27 all claims Plaintiff may have relating to EAJA attorney fees and costs in connection with this action.

28 This award is without prejudice to the rights of Plaintiff's counsel to seek Social Security Act

1 attorney fees, under 42 U.S.C. § 406, subject to the offset provisions of the EAJA.
