Action filed: December 8, 2005

1 1. WHEREAS, in an order dated September 9, 2008 (Doc. 131), the Court approved
2 the parties' agreement to the following briefing schedule for Plaintiffs' motion for class
3 certification: Plaintiffs will file their motion for class certification on or before February 11,
4 2009; Defendants will file their opposition to Plaintiffs' motion for class certification on or before
5 April 11, 2009; and Plaintiffs will file their reply to Defendants' opposition on or before May 6,
6 2009;

7
8 2. WHEREAS, Local Rule 7-2(b) limits the total number of pages for a notice of
9 motion and memorandum of points and authorities in support thereof to 25 pages of text, and
10 Local Rule 7-4(b) limits the total number of pages for an opposition to a motion to 25 pages of
11 text and limits the total number of pages for a reply to an opposition to 15 pages of text;

13 3. WHEREAS, Plaintiffs seek certification on behalf of a class alleging claims under
14 Title VII, 42 U.S.C. § 2000e *et seq.*; 42 U.S.C. § 1981; and California's Fair Employment and
15 Housing Act, Cal. Gov't Code § 12940 *et seq.*;

16 4. WHEREAS, the parties have met and conferred and anticipate that in order
17 adequately to brief the factual and legal issues pertinent to this motion, it is necessary to request
18 the Court's permission to exceed the page limits established in Local Rules 7-2(b) and 7-4(b);

19 THEREFORE, the parties hereby stipulate to the following, and request that the Court so
20 order:
21

22 1. Plaintiffs may file a notice of motion for class certification and memorandum of
23 points and authorities in support thereof not to exceed ³⁵~~45~~ pages, on or before February 11, 2009;

24 2. Defendants may file an opposition to Plaintiffs' motion for class certification not
25 to exceed ³⁵~~45~~ pages, on or before April 11, 2009; and

26 3. Plaintiffs may file a reply to Defendants' opposition not to exceed ²⁰~~25~~ pages, on or
27 before May 6, 2009.

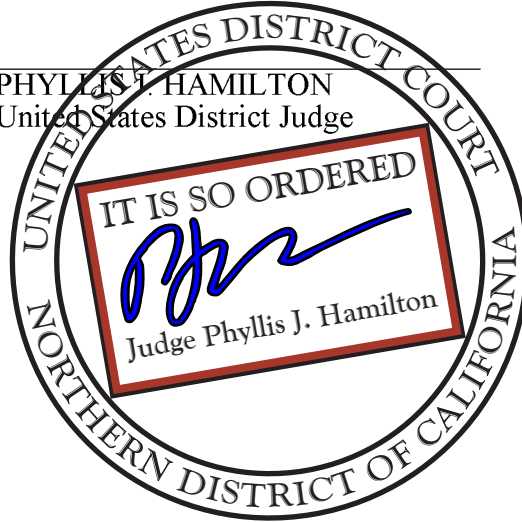
