 23 material witness in proceedings in this case **beginning on March 9, 2009, at 1:00 p.m.**, is

9 return the inmate to the California Correctional Institution.

10 2. The custodian is ordered to notify the Court of any change in custody of this inmate  
11 and is ordered to provide the new custodian with a copy of this writ.

12 **WRIT OF HABEAS CORPUS AD TESTIFICANDUM**

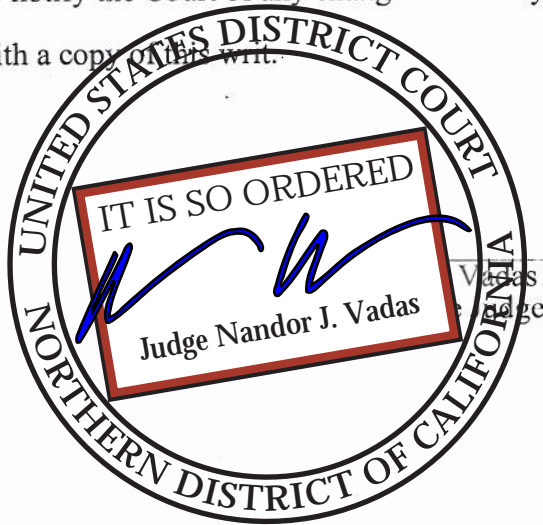
13 To: The Warden of the California Correctional Institution,
