Plaintiff has previously been granted an extension of time to file his 12 opposition, which is due on May 18, 2009. 13 In his notice of a change of address dated April 27, 2009, Plaintiff claims that he will soon 14 be transferred to Centinela State Prison in Imperial, California. He states that at his current place of 15 incarceration, California Correctional Institution, he has been denied access to the law library and to 16 his legal property. He states, "Hopefully [in the] new institution the circumstances are less awkward 17 and I can now finally respond to Defendants['] summary judgment." (Pl.'s Notice at 1.) Having 18 read and considered Plaintiff's request, and good cause appearing, 19 IT IS HEREBY ORDERED that Plaintiff's second request for an extension of time is 20 GRANTED.
