If 18 plaintiff fails to file this declaration in the time provided, or if the declaration 19 fails to establish that plaintiff is entitled to relief under Rule 60(b)(6), then the 20 Court will deny her Motion to Reopen Case [Docket No. 21]; Motion to Reopen 21 Case, Motion to Set Aside Order [Docket No. 25]; and Motion to Set Aside 22 Judgment [Docket No. 34]. 23 Docket No. 36 at 6. 24 The Order was entered in the docket on September 5, 2008. Plaintiff's declaration was thus due or 25 before September 19, 2008. Plaintiff did not file a declaration or any other type of response by this 26 deadline or after it. 27 ///
