**ORDER DIRECTING UNITED STATES
MARSHAL TO PERSONALLY SERVE
DEFENDANT A. HEDGPETH
PURSUANT TO FRCP 4(e)(2)**

This Order concerns the matter of service upon Defendant A. Hedgpeth, identified by Plaintiff as a former associate warden at Salinas Valley State Prison. The Court notes that Defendant Hedgpeth is now the warden at Kern Valley State Prison (KVSP).

Good cause appearing therefor, the United States Marshal is hereby ORDERED to attempt to effect personal service upon Defendant Hedgpeth. The United States Marshal shall serve Defendant Hedgpeth "personally" or serve an agent of Defendant Hedgpeth "authorized by appointment or by law to receive service of process." Fed. R. Civ. P. 4(e)(2).

The Clerk shall provide the United States Marshal with the necessary summons and copies of: (1) the complaint (docket no. 1) and the amended complaint (docket no. 8) as well as copies of all attachments thereto; and (2) a copy of this Order. The United States Marshal shall attempt personal service at that address within **fourteen (14) days**. The Clerk shall include on the summons form, USM 285, the following special instructions:

Pursuant to Rule 4(e)(2), the United States Marshal shall serve Warden A. Hedgpeth "personally" or serve an agent of Warden A. Hedgpeth "authorized by appointment or by law to receive service of process." Fed. R. Civ. P. 4(e)(2). The address for such service shall be at KVSP.

IT IS SO ORDERED.
